With reference to the subject cited above, I am directed to inform you that, based on the Issue of Final recognition NOC by DMET(O) vide Letter No. 10962//MET-III-Pharmacy-05/2024, dated 21/06/2025, consequent upon Govt. Approval, the Affiliation is issued in favor of Batakrushna College of Pharmacy, At-Anlajuba, Po-Darlimunda, Dist-Nuapada, Pin-766105 for D. Pharm course for the academic session 2025-26.

The Affiliation for D. Pharm is subject to the following conditions:

1. The Affiliation is valid for the academic session 2025-26 only.
2. The institution shall not admit students without prior approval of PCI, New Delhi for D. Pharm course.
3. The institute shall submit a copy of the approval letter of PCI, New Delhi for D. Pharm course to Odisha State Board of Pharmacy, Bhubaneswar before commencement of the admission procedure.
4. No admission shall be made beyond the validity period of the provisional Consent of Affiliation and the approved intake capacity by PCI, New Delhi.
5. The institution shall take admission to D. Pharm course only through Combined Counseling for Paramedical & Allied Medical Sciences conducted by DMET(O), Bhubaneswar as per Govt. of Odisha guidelines.
6. The inspection of the institution shall be carried out by Odisha State Board of Pharmacy, Bhubaneswar at any point of time during the academic session and institution shall cooperate during the inspection(s).
7. The institution shall ensure to rectify the deficiencies pointed out during the inspection(s) and submit compliance to Odisha State Board of Pharmacy, Bhubaneswar.
8. The institution shall submit the document(s) related to D.Pharm course as required from time-to-time by Odisha State Board of Pharmacy, Bhubaneswar.
9. The Affiliation shall stand withdrawn on its own, in case there is a violation of the guidelines/conditions prescribed by the Govt. of Odisha and/or PCI, New Delhi and/or Odisha State Board of Pharmacy, Bhubaneswar.
